DESIGNATION OF DEPOSITORIES RESOLUTION

WHEREAS the Board of Trustees has determined that Village Law 4-412(2) (3) requires the designation of banks or trust companies for the deposit of all village monies, designation of control, signatory, and establishment of certain accounts:

That all claims against the General Fund and Water Fund be drawn to the order of the Treasurer (or Deputy Treasurer) order countersigned by the Mayor and the Administrator, and to become a direct draft through the official depository when countersigned by the Treasurer (or Deputy Treasurer), with the exception of salary checks, which shall be signed by the Administrator alone, and in the event of the absence by the Mayor, the Deputy Mayor shall act in his stead.
- <u>Section 3.</u> That the Trust and Agency Fund, Capital Project Account, General Fund Money Market Account, Water Fund Money Market Account and the UA-CATV Account shall be authorized by the Treasurer (or Deputy Treasurer) or Administrator alone.
- Section 4. That this resolution shall take effect immediately and upon the satisfactory completion of all Banking requirements.

DESIGNATION OF OFFICIAL NEWSPAPER RESOLUTION
